Biographical Note

The son of Russian immigrants, Eli Rock (1915-2000) was born in Rochester, New York. He earned his undergraduate degree from the University of Rochester in 1937 and a degree from Yale Law School in 1940. He practiced law briefly before moving to Washington, DC, and joined the War Labor Board. He was the regional director of disputes for the board from 1942-1944, then entered the American Field Service and was an ambulance driver in France. He remained in Europe to work for the American Joint Distribution Committee from 1945-1947, first in Paris and then as directors of the Berlin Office. In 1947-1948, he served in the New York office working on cases involving heirless Jewish property.

Eli Rock was a labor arbitrator who once served as labor-relations advisor for the City of Philadelphia. He was an adviser to Mayors Joseph Clark and Richardson Dilworth, serving from 1952-1960. In his role as the city's labor consultant and later as an arbitrator, Eli Rock took part in many high-profile disputes including the 1956 wildcat strike by the Transport Workers Union against Philadelphia Transportation Co., the forerunner to SEPTA. Eli Rock's work for the City of Philadelphia ended with the election of Mayor James Tate. He later served as an arbitrator in strikes by employees of SEPTA and the Philadelphia Gas Works, both in 1971.

Scope and Content Note

The Eli Rock Collection contains personal correspondence, bills and receipts, arbitration correspondence, arbitration decisions and awards, books, and other sundry items from 1940-1999.

The Eli Rock Collection is housed in 28 archival boxes arranged in four series. Series have been designated for office files, arbitration decisions, books, and artifacts. This collection contains personal correspondence, bills and receipts, arbitration correspondence, arbitration decisions and awards, books, and other sundry items. The bulk of the collection contains American Arbitration Association decisions spanning a 40-year period, significant correspondence and some decisions regarding the Philadelphia area garment industry, Mack Truck and Lukens Steel awards round out the arbitration decision series and constitutes the most extensive and important part of the collection.

Series Descriptions

The Eli Rock Collection is housed in twenty- eight archival boxes arranged in four series.

Series 1: Office Files

Series 1, office files, materials from the War Labor Board circa 1940's, personal correspondence from, and to, a wide variety of personal and professional contacts and is arranged by year. Also contained in series one are, billing records, notes of classes taught at the University of Pennsylvania School of Law for Professor Bob Gorman, and speeches and articles presented at various conferences. The bulk of this series contains correspondence and some decisions in the Philadelphia area garment industry. Some of the garment industry material overlaps series 2

(Decisions) but was kept in series 1 due to the manner in which the materials were originally filed. There are also various Collective Bargaining Agreements from a variety of industries. Rounding out series 1 is an original copy of a 1936 term paper written by Rock entitled "Ice Wagon Drivers and Helpers Local Union 398" with a 1954 letter from Local 398, and "The Eli Rock Chronicles", as told to Ellen Feldman, recorded May 1993 to April 1995.

Series 2: Arbitration Decisions

Series 2 composes the bulk of the collection and is further divided into two sub-series by date range as originally found. The first sub-series contains binders of American Arbitration Association awards and are further divided into four parts. The first part is in binders filed alphabetically by company from the 1950s to the early 1960s and contains 160 decisions. The second part of the first sub-series is organized in the same manner and picks up where the first part leaves off and continues to 1980. This contains the bulk of the Series 2 and contains 1101 decisions in 50 binders.

Series 3: Arbitration Decisions

The third part is again organized like the first two parts and covers 1980 to the early 1990s containing 223 decisions in 19 binders. Part four contains 133 decisions from the same date range as part 3 (1980 to early 1990s), however these decisions are not in binders. Sub series 2 contains seven binders, each containing decisions from a particular company, and two binders containing 344 decisions of Lewis Gill for Mack Trucks and UAW. Series three contains several binders of Steel Arbitration Awards arranged by year, some of which contain Rock decisions. Also in series 3 are Proceedings of the National Academy of Arbitrators from 1955 to 1999, and various textbooks on arbitration and public sector bargaining.

Series 4: Rolodex Files

Series 4 contains 2 Rolodex files of phone numbers of personal and professional contacts, a phonograph record, an ashtray used by Eli Rock, and various certificates.
