#### **Scope and Content**

Manuscript Miscellany is housed in eight archival boxes and selected documents are housed in a fireproof safe. Manuscript Miscellany contains various documents, correspondence, books and other small collections of items related to authors, politicians or other notable/local individuals or institutions.

This manuscript group is an assortment of small collections which range in size from a single page to one or two volumes of documents. This collection is constantly expanding, and includes items such as letters written by Carl Sandburg, Upton Sinclair, and George Bernard Shaw, a day book recorded by the J.W. & S.G. Kuntz Mill in Troutville, PA from 1899-1925 and a War Ration Book from the Second World War. Other documents include patents signed by John Quincy Adams, and a royal commission signed by King George III in 1795.



You are therefore to take the said Company into your Care and Charge and duty to Exercise as well the officers as Soldiers Thereof in Arms and to use your best Endeavors to keep them in good Conduct

and Discipline. And We do hereby Command Them to obey you as their Captain and you are to observe and follow such orders and Directions from Time to Time as you shall receive from Us your Lieutenant Colonel Commandant as any other of (sic) your Superior Officer, according to the Rules and Discipline of War in pursuance of the Trust hereby reposed in You. Given at Our Court at Saint James the Twenty eighth Day of January 1795 In the Thirty fifth Year of Our Reign. Entered with the Secretary M. Seurs. Entered with the Commissary (sic) General of Musters "Thomas Butts" By His Majesty's Command
